


# 1. The Role of Member Meetings in Governance

In-person meetings remain a vital option, offering operational efficiency and deep engagement through tools like seamless agenda management, secure voting, and professional facilitation.



Technology is a cornerstone for supporting associations' governance needs, ensuring inclusivity, compliance, and trust across hybrid, virtual, and in-room meeting formats. By leveraging the right tools, associations can enhance accessibility, secure data, and provide seamless member experiences.

Key benefits of governance technology include:

• End-to-End Verifiability for Elections: Simon Bryan, Managing Director at Lumi Global, explains, "A voting platform needs to be able to prove a three-step process: one, a ballot has been cast as intended; two, those votes have been received in the same way they were cast; and three, ultimately, those votes are counted in the same way as they were received." This rigor ensures election integrity across all formats.

• Data Security and Compliance: Advanced encryption and secure data storage protect sensitive member information and ensure adherence to regulations such as GDPR or CCPA.







- Comprehensive Audit and Reporting: Real-time reporting, anonymized voter data, and rigorous compliance features—such as penetration testing and certification audits—build transparency and trust.
- Seamless Integration with Existing Tools: Modern platforms integrate smoothly with CRMs, email marketing tools, and other association software to reduce administrative effort and improve efficiency.
- Enhanced Member Engagement: Interactive features like live Q&A, real-time polling, and equitable access to debate for virtual attendees maintain inclusivity and encourage active participation.
- Optimized In-Room Features: Speaker queuing and instant voting technologies streamline physical meetings, ensuring efficiency and professional delivery without manual processes.



# 3. Engagement Strategies for Meetings Across All Formats

Effective engagement strategies are essential to foster inclusivity and active participation in hybrid, virtual, and in-room meetings. By tailoring approaches to each format, associations can create seamless and meaningful experiences for all attendees.

#### • Hybrid Engagement:

- Acknowledge virtual participants by recognizing their numbers and rotating speaking opportunities between in-room and online attendees to build inclusivity.
- Ensure visual equity with AV technology that displays both in-room and virtual participants equally, avoiding the perception of a "two-tier" meeting structure.
- Use interactive features like live polls, chat functions, and breakout rooms to maintain engagement throughout the session.
- In-Room Engagement:
  - Leverage tools like speaker queuing and live voting to streamline participation and enhance decisionmaking efficiency.
  - Provide advanced display solutions for real-time visibility of discussions and voting outcomes, ensuring transparency and clarity.

- Universal Preparation and Follow-Up:
  - Distribute pre-meeting materials, instructional guides, and host "test your tech" sessions to familiarize attendees with platforms and processes, regardless of their attendance format.
  - After the meeting, share recordings, key takeaways, and action items to ensure all participants remain informed and connected

Virtual attendees should not only actively participate in the decision-making process during member meetings but also have full access to meeting materials and the opportunity to engage in meaningful debate."

# 4. Building Trust Through Transparency

Transparency in processes, particularly elections, is vital for fostering trust within associations.

Compliance Measures:

Engage parliamentarians for major meetings and partner with audit firms to ensure election integrity. Adhering to welldocumented processes reassures members of the fairness and validity of outcomes.

• Member Communication:

Clearly outline voting procedures, provide candidate bios, and offer reminders to encourage participation. Regular updates on the progress of election processes and outcomes help maintain transparency.

 Inclusivity in Governance: Avoid centralizing decision-making power within leadership, which can alienate members and erode trust. Associations must prioritize member involvement to maintain engagement and credibility.

- Visualizing Transparency: Provide detailed, real-time dashboards during elections to showcase voter participation rates and compliance checkpoints without compromising anonymity.
- Encouraging Feedback: Establish open channels for members to provide feedback on governance processes, ensuring continuous improvement and fostering a culture of trust and collaboration.

Ensuring the integrity of elections relies on a clear three-step process: votes must be cast as intended, received as cast, and ultimately counted and reported accurately. To achieve this, the user interface should simplify voting, and verification mechanisms—whether on-screen or through a receipt—must provide participants with confidence in the process. Real-time reporting, audit logs, and strict anonymity measures ensure trust while safeguarding against undue influence or breaches of confidentiality. This concept of separating votes from voters is central to secure, transparent, and inclusive elections."

# Driving Member Participation Across Formats



The National Association of Realtors (NAR) successfully transitioned to hybrid governance meetings following the pandemic, demonstrating how technology and strategic planning can enhance member participation. Facing a diverse membership of 1.5 million professionals spread across various geographies, NAR recognized the need to adapt their traditional meeting formats to be more inclusive and accessible.

#### The Challenge

NAR aimed to maintain the high participation rates seen during their in-person gatherings while addressing the growing demand for virtual access. Their challenge was to create a seamless experience for both in-room and remote attendees, ensuring that every member felt included and empowered to contribute.

#### The Solution

To meet these needs, NAR implemented a hybrid meeting model, supported by secure, transparent voting technology and an emphasis on inclusive practices. This included:

Accessible Platforms:

Leveraging tools that enabled members to join discussions and vote in real time, regardless of their location.

Transparent Processes:

Providing real-time reporting and verification to ensure members' confidence in the integrity of the outcomes.

Engagement Strategies:

Offering interactive features, such as moderated Q&A and live polls, to encourage participation from remote and in-person members alike.

#### The Results

By embracing a hybrid model, NAR achieved:

Increased Participation:

Members who previously faced barriers to attending, such as travel constraints, were now actively involved in governance decisions.

• Higher Engagement:

The combination of accessible technology and inclusive policies led to a significant rise in member interaction during meetings.

• Enhanced Trust:

Secure voting systems and transparent reporting ensured that all participants, regardless of format, felt their contributions were valued and counted.

- Tailor Onboarding:

Equip board members and volunteers with comprehensive training and resources to enhance their readiness.

There are three key takeaways to ensure success for associations. First, prioritize engagement by using tools that seamlessly include both virtual and in-person participants in a way that feels natural and drives meaningful interaction. Second, ensure compliance with secure, transparent voting and proper education to meet governance standards. Finally, build trust through transparency by implementing systems that provide end-to-end verifiability, particularly during elections, to instill confidence in the process and outcomes."
